EVENTS INCLUDED NATIONALLY TOURING ARTISTS PRESENTED BY CVCA, SELF-PROMOTED SHOWS SUCH AS VOICE MALE, AND LOCAL PRODUCTIONS BY UTAH FESTIVAL OPERA AND MUSICAL THEATRE, MUSIC THEATRE WEST, CACHE VALLEY CIVIC BALLE, AMERICAN FESTIVAL CHORUS, PICKLEVILLE PLAYHOUSE, CACHE THEATRE COMPANY AND OTHERS. WE PROVIDED SIX STUDENT MATINEES OF NATIONALLY TOURING PRODUCTIONS TO 4,914 LOCAL CHILDREN FREE OF CHARGE. VOLUNTEER USHERS DONATED 7,800 HOURS FOR THESE EVENTS.
