EVENTS INCLUDED NATIONALLY TOURING ARTISTS PRESENTED BY CACHE ARTS, SELF-PROMOTED SHOWS SUCH AS VOICE MALE, AND LOCAL PRODUCTIONS BY UTAH FESTIVAL OPERA AND MUSICAL THEATRE, MUSIC THEATRE WEST, CACHE VALLEY CIVIC BALLE, AMERICAN FESTIVAL CHORUS, PICKLEVILLE PLAYHOUSE, AND OTHERS.
